## **DUTIES AND RESPONSIBILITIES:**

Under the direction and supervision of the Team Lead and Supervisors of Operations Control Centre, the Acting Operations Controller - LRT is responsible for maintaining the safety, quality, and efficiency of LRT service. Primary duties include:

- Providing customer service, including leadership and direction to Calgary Transit Operators through Calgary Transit's Radio Communications Network.
- Ensure uninterrupted delivery of LRT service by addressing and solving issues and acting as the first point of contact in emergencies.
- Frequently communicating service status updates to external customers and internal stakeholders, especially during disruptions.
- Completing reports for all incidents and occurrences, and ensuring all information is properly documented and tracked to ensure divisional objectives are met.
- Collaborate with internal and external partners to highlight safety initiatives.

## **QUALIFICATIONS:**

- The successful applicant will possess a minimum of a High School diploma or equivalency (e.g., G.E.D.). If education is acquired outside of Canada an IQAS assessment is required.
- A minimum of one year of public transit experience is required. Preference will be given to those with Operations Control and/or LRT mainline operating experience.
- The successful applicant requires a clear and understandable speaking voice, and the ability to communicate effectively in written form, as frequent e-mail and report writing is required. A high level of proficiency in Microsoft Office and general computer use is required these skills will be tested.
- The applicant must possess excellent interpersonal skills, and the ability to work closely and effectively together with a wide variety of other employees in a busy team environment, and a noisy shared workspace.
- Must be able to remain focused, calm, and highly effective in emergency and extremely stressful situations. Success in this position requires relationship building, conflict and time management skills.
- The successful applicant must be able to obtain LRT rulebook, right-of-way, and mainline operating proficiency.
- A good understanding of Calgary Transit's LRT system, service levels, and Customer Commitment are beneficial.
